VANCOUVER YOUTH SOCCER ASSOCIATION POLICY REGARDING NON-COMPLICANCE

The purpose of the Society is to foster, develop and govern the game of soccer within the City of Vancouver and the University Endowment Lands and to enforce the Constitution, Bylaws and Rules and Regulations of the British Columbia Soccer Association.

Non-compliance shall mean that a club has:

- missed a deadline;
- not paid fees owing to the District;
- not provided the District with pertinent electronic data such as completed workbooks and/or required paperwork such as POAs, BCSA photo ID, etc.

Failure to comply with any deadline may result in a \$100.00 fine per team not in compliance.

For the purposes of the regular playing season further non-compliance, after one reminder, may result in **teams either not being included in the scheduling process if the non-compliance is related to June 23, August 15 or mid-September ITP or Registration requirements** or **withdrawal of services to the Club** by means of removing the outstanding teams from existing league and cup schedules until the club has provided the documents, information or fees requested by VYSA.

Note: Withdrawal of services from the Club applies to all leagues and schedules from U6 through U18, boys and girls, and includes any U6 to 10 Club in-house schedules.

These games will not be made up and refunds will not be issued for field time not used due to cancellation of games for non-compliance.

Also in addition, and as per the VYSA Performance Bond Schedule, Improperly Filled-out Forms fines will take effect.

NOTE: BCSA Rule 4, Affiliation:

b) Only properly affiliated teams shall be eligible to participate in competitions under the jurisdiction of the Association.

i) All teams must be affiliated in the format authorized by the Association.

k) A "team", U-13 through Adult, shall be recognized when a minimum of eleven (11) players unless the team is an approved small sided team as specified in Rule 2 e are registered with the Association's Registrar or designate under one team name.

n) A "small sided-team" shall be recognized when a minimum of the number of players specified in the table below (U6-U12, or as approved under Rule 2 e) are registered with the Association Registrar or Designate under one team name.

BCSA Rule 5, Player Registration:

f) Any player or official not registered with the Association shall be determined to be ineligible to participate in league and cup competition under the jurisdiction of the Association and no longer eligible for any benefit from membership in the Association. For the purposes of this section registration shall cease at the end of the playing season as specified in Rule 3.

Any club administering **camps or academy sessions** and who have not registered their participants at least 24 hours before the first session are subject to the following:

As per BCSA Discipline Sanctions: Failure to register players - Participated in an organization's on not to register some, or all of its players and teams with the BCSA; and Leagues, Divisions, coaches and administrators are liable to an:

A Fine of \$50/per player up to \$5,000; plus registration fees, and a 12 month administration suspension. *An administrative suspension, or full suspension, is a complete prohibition against participating in any sanctioned soccer activities for the duration of the suspension*
